#### 1.02 Call to Order

# 2.01 Superintendent Applicant Interviews, Confidential Document Review, Negotiations and Legal Advice

session as authorized by the following provisions of the Colorado Open Meetings Law: C.R.S. § 24-6-402(4)(c), to meet with the applicants for the position of superintendent whose identity is required to be kept confidential by C.R.S. § 24-72-204(3)(a)(XI); C.R.S. § 24-6-402(4)(g), for consideration of documents submitted by applicants for the position of superintendent which are protected by the mandatory nondisclosure provisions of the Colorado Open Records Act, C.R.S. § 24-72-204(3)(a)(XI); C.R.S. § 24-6-402(4)(e), to determine positions relative to matters that may be subject to negotiations with finalists for the position of superintendent; and, C.R.S. § 24-6-402(4)(b), to conference with an attorney for the district for the purpose of receiving legal advice regarding the superintendent search process.
