Representatives of the Safety and Security Community Task Force presented conclusions following months of work together following the national school safety framework of prevention, preparedness, response and recovery. Community members Heilit Biehl, Lisa Cook, Kristy Debrowski, Shawna Fritzler, Jason Thompson and Karen Tonso represented four areas of task force focus: climate & culture, threat assessment & management, tactics & response, and target hardening/physical safety. The task force recommendations (28) will be in the final report released October 19 with a foreword by Superintendent Dr. Jason Glass and the district response/implementation plan. (Attachment E)

Board discussion covered lockdowns, locking doors, early warning signs and their communication of such, expertise of law enforcement partners, mitigating hazards, School Resource Officer (SRO), assistant principal and teacher roles, access to schools, active shooters, understanding of fellow committee members (overarching themes), student training, target hardening, social media monitoring, engagement in schools by students and community, availability of extra-curricular activities.

Board members thanked all task force participants and staff for the in-depth work completed on behalf of the school district and Jefferson County residents.
